Might we suggest *Hidden Figures* (the story of the pivotal role played by African American women in NASA's early space missions which showcases their strength and mathematical prowess), *On the Basis of Sex* (the biographical legal drama film telling the inspirational story of Ruth Bader Ginsberg, who ultimately became an Associate Justice of the United States Supreme Court) or *Erin Brockovich* (the true story of a single woman with no legal training uniting a community to fight a major corporation whose business practices caused water contamination). For the younger crowd, try Pixar's *Brave*, featuring a princess who doesn't need to be saved by a prince, but who flips the traditional fairy tale through her growth, self-reliance and courage.
